# **Justice in Action**

Tiffany met Joe online. Joe initially took care of Tiffany; he provided for her and Tiffany was in love. Not long after meeting, Tiffany and Joe got married and bought a dog. Shortly after getting married, however, a new side of Joe emerged. He was abusive to both Tiffany and their dog. After abusing her, Joe would take Tiffany's phone away from her so she couldn't call the police and he would also damage her vehicle so she couldn't leave.

After a particularly horrific evening where Joe strangled Tiffany, she finally got away long enough to call the police. Joe was arrested. From his jail cell, Joe called Tiffany several times, threatening both her and their dog's life thereby violating the temporary protective order. Tiffany wanted to protect both herself and her dog. Hurting a pet has become recognized as a marker in domestic violence cases which indicates a likelihood for future severe violence. An attorney from Legal Aid Works stepped in to represent Tiffany in her case. Our attorney convinced the judge to issue a temporary protective order to grant possession of the dog to the wife. In the final order, Joe plead guilty to violating the emergency protective order. Our attorney filed a domestic violence divorce complaint and because of our attorney, Tiffany received legal representation for a divorce, a protective order, and custody of the dog and residence. Before our attorney came to Tiffany's side, her case had been postponed several times while the threats to both her life and her dog's life continued. Many domestic violence victims are reluctant to leave an abusive situation out of concern that the pet will be harmed if the victim leaves. Legal Aid Works' attorney helped release Tiffany from the clutches of her abuser.

### Legal Term House Bill No. 972

In 2014, Virginia amended its Protective Order laws to grant petitioners possession of any "companion animal," so long as the petitioner is considered the owner. This authority extends to all protective orders, including preliminary and emergency protective orders. For the purposes of this new law, a companion animal is generally any family pet, to include dogs, cats, guinea pigs, hamsters, rabbits which are not for consumption, reptiles and birds. Farm animals, game species or animals which are being held for research are not considered companion animals for these purposes. A petitioner will be considered an owner of an animal so long as the petitioner has a property right in the animal, keeps or houses the animal, has the animal in their care or has acted as a custodian of the animal.
