

Recently, an outreach employee at Legal Aid Works (LAW) encountered a mother - who we'll call Lisa - **that was 5- months behind on her rent.** In addition to facing eviction, she faced a series of gut wrenching challenges in her personal life. Having recently **lost her job**, as a result of the pandemic, and having tragically **lost her son** due to violence, Lisa was left without any help or support system. Without LAW, Lisa never would have learned about the **VA Rent Relief program.** Without you, we would not be able to continue helping moms like Lisa find resources, learn about their rights and ultimately achieve justice.
