Justice in Action

Jenny (name changed to protect anonymity) walked into our office just over a year after she separated with her husband, Ryan (name changed to protect anonymity). Prior to their separation, **Jenny had been experiencing incidents of domestic violence over her 5 year marriage to Ryan.** On the night that instigated her leaving their marital home, Ryan was high on prescription pain killers. He violently took Jenny's phone and twisted her arm. **He began asking where his gun was in a threatening manner** which really scared Jenny. After receiving aid from a police officer, she was able to obtain a protective order against her husband.

Jenny spent the year following this incident getting her life back. She and her two children moved into a new apartment. Jenny and Ryan were able to agree to a custody, visitation, and support order through the Spotsylvania County Juvenile and Domestic Relations Court. However, something always felt unresolved to Jenny. What she really desired and needed was a divorce from her husband so she could truly take back her life and start over.

Since the couple had no unresolved marital issues – no shared debt, no shared property, and a custody, visitation, and support order in place – they were great candidates for an uncontested divorce. Our attorney contacted Ryan and ascertained that he was in agreement with a divorce and would cooperate. Paperwork was filed with the Spotsylvania County Circuit Court. A month after the process began, the court clerk mailed a Final Divorce Decree to all parties involved and the divorce was finalized. Jenny would finally have the fresh start she needed.

If Jenny tried to navigate the system on her own, it would have been very difficult for her to figure out how to draft and submit all of the required paperwork the correct way. The process is very complicated and not user friendly. It took several divorce complaint templates, obtained from law books and from other attorneys, to draft one tailored to their exact situation. The complaint had to be filed with two important and specific court documents. Next, Ryan had to come to the LAW office to receive a copy of the complaint and sign another court document in front of a notary. This step cannot be completed before the complaint is filed or you have to start over.

Once Ryan "waived" his service of the complaint, a plaintiff affidavit for Jenny was drafted and one for her third party witness (a neighbor). Jenny and her neighbor had to come to the LAW office, review the affidavits, and sign them in front of a notary. The affidavits were filed with the final divorce decree, which were also drafted using several templates. This process is often done wrong and the paperwork is not accepted by the court when people try to do this without legal help. Luckily for Jenny, the final divorce decree was timely entered without having to start the process over. **Without a Legal Aid attorney, Jenny may have never obtained a divorce from her abuser.** With new funding from a Victims of Crime Act grant, Legal Aid Works hired new staff to handle divorces for Domestic Violence victims like Jenny.
