


## How you can help...




“Janine” had worked for the property manager of her apartment, and he took the amount of rent she owed out of her paycheck in odd, difficult-to-calculate ways over the past several years. The landlord evicted her illegally at the end of March during the height of the pandemic “shelter in place” order. Janine was lucky that the police she called convinced the landlord to let her back in. Both the landlord and the property manager filed separate eviction cases against Janine, even though only the landlord has the authority to file for eviction, and she is now facing those two eviction cases scheduled for May, with the false claim that she owes \$7,000 in back rent.

Our staff attorney advised Janine about her rights, and pointed her to our “Know Your Rights” brochure about how to file an “Unlawful Exclusion” complaint at court. If the courts are reopened by the time Janine has to face her landlord and property manager in May, Legal Aid Works will be there to assist her.
